 - a. 25th Ward Thanksgiving Feast: Juarez w/ Ald. Sigcho-Lopez
 - i. This Sunday, 11/23 10a-2p at Juarez
 - ii. Open to all families of Juarez via as well as open to community via registration
 - b. Flesh: Juarez fall play
 - i. 11/21 @3p, 11/22 @3p & 7p, and 11/23 @3p
 - c. Revised school calendar
 - i. New student attendance days to recover instruction lost during CTU strike days: 11/27, 1/2, 1/3, 6/17, 6/18
 - d. Automotive academy
 - i. Not able to find a replacement instructor despite numerous applicants, missing necessary certifications
 - ii. Current instructor is Omar Martinez (assistant to Valdez for the past three years) does not have certifications and is not a teacher, so is not a long-term solution
 - iii. If necessary, may have to close the program and put students into other classrooms with certified teachers. That would increase classroom sizes as there is no funding for a teaching position outside of CTE and we are unable to open a new CTE course at this time.
 - iv. Concern for seniors currently in the program given the lack of certified instruction and what happens to them if the program is closed
 - v. Ocon suggests that the LSC decides the future of the program in December if a properly certified teacher is not hired
