- 1. Call meeting to order
 - a. Rosa Esquivel
- 2. Roll Call
 - a. Ocon, Pedra, Ms Bigelow, Ismae, Rosa, Esmeralda, Alicia Fraga, Ingrid Garcia
- 3. Approve minutes
 - a. Ismael motions, Ms. Bigelow and Oscar second the motion; all approve
- 4. New Business
 - a. Mr. Cuevas: Acre of land
 - b. Letter to 25th Ward Alderman
 - -Ish explained issue of land (located on 21st/Laflin) in the letter and read the letter.
 - Sr. Pedra stated he met with alderman re issue of land.

 - c. Ms. Bigelow figure out a way that the CIWP meetings are announced on the marquee, or at least to announce that parents can be involved
